OSDBU establishes specific contract requirements using individual BPA call awards that are based on a firm-fixed-price basis using fixed-priced labor rates.

Call #0016 - Under this call Monterey provides support services to the VA Veterans Benefits Administration (VBA) and Office of Strategic Planning (OSP). The primary focus of the BPA Call is to develop plans to integrate PPBE capabilities at VBA. Monterey is assessing VBA's current capabilities and to help develop and institutionalize OSP PMO approved processes and organizations which support a fully developed PPBE process integrated with the overall VA PPBE framework. We also provide administrative and program management support; change management facilitation and decision support services; process automation; strategic outreach; operations research and analytic support within OSP.
